1. Introductions:

Minutes of previous meeting agreed.

2. LSDC review

Agreed:

A review of the LSDC's impact and make-up will be carried out as per the scope and objectives set out in the papers, with the following additional requirements:

- Bring draft report to September Full Commission meeting for comment.
- Summarise commissioners' time contribution
- Suggestions for new mayoralty priorities?
- Commentary on the GLA's response to the LSDC's work; what more is needed to land the work politically
- Review our ways of working – subgroup structure etc.
- Review our communications approach – e.g. long reports etc.
- Host a workshop to get commission input on this.

Actions:

- **Jon:** Produce a draft report of delivery and impacts of the LSDC's work to be discussed at the September LSDC meeting. Use that meeting to workshop Commissioners' input on the questions above.

- **Jon:** Invite the GLA Assistant Director for Environment to an LSDC meeting to discuss the LSDC's work.

3. Just transition

- LSDC's Just Transition Report will launch on 26th June at an event at the RSA.

Actions:

- **Jo / Jon :** set up meeting with London Councils and TEC Chair to develop a dialogue with boroughs on how they might implement the report's recommendations
- **Jon:** Develop guidance to embed JT in retrofits by policy officers.
- **Leonie:** Flag the report with Deputy Mayors.

4. Social value

- The LSDC will submit case studies of social value best practice to be included in the GLA's Annual Monitoring Report ('AMR') of the London Plan. Commissioners were invited to provide suggestions.
- Work is underway to develop LSDC recommendations for social value input to the new London Plan. A series of workshops will gather community and stakeholder input, which will be compiled into a report submitted by the LSDC into the Planning for London process.

Actions:

- **Maria / all Commissioners:** provide SV case studies by 27 June.
- **Secretariat:** Liaise with RTPI and UKGBC to check ideas are aligned and share thinking with other regions.

5. London Climate Action Week

Actions:

- **Ashok** to provide an LSDC quote for the GLA's press release for the Mayor's Green Finance announcement.

6. AOB:

London Climate Resilience Review

- The Mayor has commissioned an independent review of climate adaptation in London with recommendations for policy-makers. A call for evidence will be issued soon and the report will be published in November / December.

- It aims to identify top risks for London. The LSDC could propose adding food and water security to the scope and encourage them to embed LSDC's just transition recommendations.

Agreed: The LSDC will respond to the Resilience Review's call for evidence.

Actions:

- **Secretariat:** Coordinate LSDC input to the Resilience Review's call for evidence. Arrange meeting with Ashok and the LCCP Chair to discuss respective submissions.
