#### Petition for the Transfer of the GLC's Coat of Arms to the GLA

Following recent informal discussions with your office, the Assembly is delighted to have confirmation of your continued support for the submission of a formal petition to His Majesty the King, via the College of Arms, for the transfer of the former Greater London Council's Coat of Arms to the GLA and of your support for the display of a physical Coat of Arms within City Hall.

As you will recall, the Assembly first raised the issue of the transfer of the Coat of Arms with you, on a unanimous and cross-party basis, in 2020. The Coat of Arms is an important part of further entrenching the GLA's identity and in building the fabric of new City Hall as a civic space for London with strong roots and connections to London's proud devolved history. We welcome the opportunity to collaborate with you with those aims in mind.

In terms of next steps, Secretariat officers will be asked to prepare a Mayoral decision form for your signature. A formal Mayoral decision is sought as it is not within the Assembly's statutory powers to initiate the petition. However, the Assembly will pay, from its own component budget, for the associated costs - namely the petition fee, fees for digital art work and for architect's advice ahead of the commission of a physical Coat of Arms. The Assembly also anticipates meeting the costs for the commission and manufacture of a physical Coat of Arms. Officers will work with those in your office and in Facilities Management regarding the placement of any Coat of Arms in due course.

The Executive Director of Secretariat will lead on the preparation and submission of the petition and all associated matters, under the General Delegation and in consultation with the Assistant Director of External Relations.
