Title: Confirmation Hearing for the Role of Co-Chair of the Mayor's Cultural Leadership Board

1. Executive Summary

- 1.1 In accordance with the Assembly's Standing Orders and the provisions of Schedule 4A to the GLA Act 1999 (as amended), the Chair of the Assembly has delegated authority to: (i) decide whether to hold a confirmation hearing for the Mayor's candidate for appointment to the office listed in section 60A(3) of the Act; and (ii) to request that the Mayor's candidate for appointment produce, under paragraph 6(4) of Schedule 4A of the Act, documents that relate to his or her proposed appointment.
- 1.2 The Chair of the London Assembly received a letter from the Mayor of London on 16 January 2025 indicating his intention to appoint Amanda Parker and Tom Sleigh to the role of Co-Chairs of the Mayor's Cultural Leadership Board. A copy of the letter from the Mayor is attached at **Appendix 1**.
- 1.3 Following receipt of the letter and informal consultation with party Group Leaders, the Chair of the London Assembly has decided to hold a confirmation hearing in relation to the proposed appointments, and to ask the candidates to provide CVs and supporting statements. Copies of the Chair's letters to Amanda Parker, Tom Sleigh and the Mayor are attached at **Appendices 2, 3** and **4**.

Proposed appointment to the role of Co-Chair of the Mayor's Cultural Leadership Board

In accordance with the Greater London Authority Act 1999 (GLA Act) section 60A(2), I am writing to notify the London Assembly that I propose to appoint Tom Sleigh and Amanda Parker to the role of Co-Chair of the Mayor's Cultural Leadership Board.

Tom is currently Group Corporate Affairs Director at the Bank of London and Chair of the Norwich Theatre. He represents the ward of Bishopsgate in the Square Mile and sits on the City Corporation's Policy and Resources Committee, its Culture, Heritage and Libraries Committee, and its Finance Committee. Tom was recently re-elected to serve a fourth year as Chair of the City of London Corporation's Barbican Centre Board. His tenure has seen a major programme of organisational and governance change and kick-started a period of cultural change within the institution. From September 2024, he has also been the Chair of the Council of Goldsmiths, University of London.

I propose to appoint Tom as Co-Chair alongside Amanda Parker, who is the most recent Vice-Chair of the Board. Amanda's career spans screen, broadcast, arts and culture, including Director, London Short Film Festival and Editor of Arts Professional magazine. She founded Inc Arts UK, which from 2019-2022 led national advocacy representing the UK's ethnically diverse arts sector workforce, producing sector-leading research and EDI solutions for creative and cultural organisations.

I am proposing to appoint Co-Chairs due to the volume and breadth of work expected in the upcoming Board cycle. We are seeking an active Board, and having two Chairs with complementary skill sets will provide more resources. Our openness to flexible working was referenced in the role adverts, and it will be positive to see this modelled in new arrangements for the Board.

I note under section 60A of the GLA Act the Assembly is required to consider this proposed appointment and has the right to hold a confirmation hearing meeting, should it so choose.

The statutory confirmation process period will end three weeks from the date of receipt of this letter, within which time a meeting of the Confirmation Hearings Committee can be held if this would help the Assembly to make a recommendation about whether I should proceed to confirm Tom and Amanda's appointments.
