#### State of London Debate 2025 Consultation

Thank you for the consultation paper on the State of London Debate (SOLD) 2025.

The points raised by the GLA Oversight Committee have been as follows:

- 1) The timeframe for this consultation has been incredibly short, especially given this is an established annual event.
  - In the past, this topic has been brought forward with more appropriate lead-in times, which have allowed for scrutiny at a full meeting of the Oversight Committee. We would wish to return to this for next year's event.
- 2) Concerns were raised around security for the Mayor and Assembly Members at the most recent People's Question Time meeting, which included the following:
  - a. Entrance/exit doors for AMs and members of the public were right next to each other.
  - b. A lack of street lighting on the walking route to/from public transport/Private hire vehicle access after the event.

Can you confirm that these have been taken on board with the management of the site chosen for the 2025 SOLD?

- 3) Some Assembly Members have questioned the choice of chair of the June 2024 SOLD. Can you clarify:
  - a. What appraisal was made by the events team of the Chair in relation to the June 2024 SOLD event?
  - b. What process is used to select a Chair for the SOLD event?
  - c. When will the contract with LBC conclude? If it had concluded after June 2024 when was it reinstated/renegotiated?
  - d. Can the Events Team engage with the Oversight Committee over future selections for this role, and contract providers?
- 4) Recent People's Question Times (PQT) have had lower in-person attendance than during the previous administration. Have we utilised feedback from PQT and other public-facing events to feed into how we can improve attendance at SOLD? When will the venue be advertised and has a consideration been made of advertising by 'town centre' as opposed to borough?
- 5) How are we ensuring that the event is accessible both in-person and online to Londoners?
