Tracking Delivery of the Mayor's 2024 Manifesto Commitments

I am writing to you on behalf of the Budget and Performance Committee to share our observations and recommendations regarding the delivery of your 2024 manifesto commitments. The Committee met last month to review progress on your 2024 pledges, a third of the way into this mayoral term. We also considered how the GLA's new governance approach—using mandates and delivery plans—will be used to track and support the delivery of these commitments. The Committee's key findings are outlined below.

Tracking manifesto commitments

We would like to thank your office for providing the full list of your 2024 manifesto commitments in advance of this meeting. Of the full 146 commitments shared with the Committee, we have heard from your Deputy Chief of Staff Richard Watts that, "There are 20 [commitments that are] done. We are very confident about the vast majority of the rest of them. A couple of them are dependent on external funding that we cannot make guarantees around and there is one we think at the moment where the Mayor has made his position clear on it that is not going to be met."

The Committee acknowledges that external funding constraints may make some commitments harder to deliver. However, we would like to see greater transparency, not only in reporting what has been achieved, but also in setting out what remains achievable within the term, and where delivery

may face challenges. In response to this letter, the Mayor should provide a clear breakdown of manifesto commitments, specifying which have been completed, which are on track, which require external funding or changes to staffing, and which will not be delivered. This should be published in a single, public-facing document. Where commitments cannot be delivered or where the Mayor has chosen not to deliver them, then the Mayor should clearly communicate this to Londoners.

We also considered the GLA's new mayoral mandates and delivery plan framework, which is the key process whereby your manifesto becomes a policy programme within the GLA.² The GLA's Chief Finance Officer Fay Hammond confirmed that "the first quarterly performance report of the eight delivery plans that have been agreed will be published at [Quarter] 2."³ The Committee supports the introduction of performance reporting for the delivery plans. To support effective scrutiny and public accountability, the new performance reporting should include clear baselines for manifesto commitments, regular updates, and greater transparency for both the Committee and Londoners. The GLA Chief Finance Officer should ensure that performance reporting for each delivery plan includes baselines for the specific manifesto commitments it is seeking to deliver, along with expected progress trajectories where appropriate — such as for environmental targets — to support effective scrutiny and accountability.

Making London safer

The Committee welcomes confirmation of the baseline for your manifesto pledge to "Work with a Labour government to put an extra 1,300 neighbourhood police officers and PCSOs on the streets." We heard that the current baseline is 35,291 police officers and police community support officers (PCSOs), based on May 2024 figures. However, there is still uncertainty around the role of Special Constables within this pledge. A separate line in your manifesto referred to delivering "1,300 more officers, PCSOs & Special Constables in local neighbourhoods across London." It remains unclear how the 1,300 figure is distributed between officers, PCSOs, and whether Special Constables are included. In response to this letter, the Mayor should provide clarification on the composition of the pledged 1,300 additional neighbourhood policing staff, setting out explicitly how many will be police officers, PCSOs, and Special Constables.

In addition, the Committee notes that one commitment out of the Mayor's full list of 146 commitments—maintaining a 24-hour police front office counter in every borough—is not going to be met. Richard Watts explained: "this is the one commitment that we have put a metaphorical red flag against. The Mayor was clear [at People's Question Time] about his view on it, and that is where we are."

Making London greener

The Committee considered your commitment to "Deliver a 100 per cent zero-emission

bus fleet by 2030."⁸ As of June 2025, Transport for London's (TfL's) zero-emissions bus fleet has reached 2,000 buses, or roughly 20 per cent of its total fleet.⁹ The remainder of the fleet meet or exceed Euro VI emission standards, the same emissions standard as the Ultra Low Emission Zone (ULEZ).¹⁰ TfL previously had a target date of 2034 for achieving a fully zero-emission bus fleet; your commitment brings this forward by four years.¹¹

The Committee heard from Richard Watts that:

"The current date is either 2034 or 2032 if nothing happens, because we are just buying electric buses now... What the Mayor is trying to do, and he is pushing TfL to be ambitious here, is to bring that target date forward in order to make the air of London even cleaner." ¹²

Richard Watts has also agreed that delivering a 100 per cent zero-emission bus fleet will require significant investments in infrastructure, including charging points across bus depots, upgrades to local grid capacity, among others. Without these wider infrastructure upgrades, the accelerated transition risks being undermined by bottlenecks in energy provision and infrastructure upgrades.

The Mayor should ask TfL to confirm what plans are in place to ensure infrastructure upgrades keep pace with bus procurement, and to share with the Committee a list of most challenging depots or locations requiring infrastructure upgrades to meet the 2030 target.

Making London more prosperous

Fares Freeze

The fares freeze featured prominently in your manifesto, but included a caveat that the freeze would only go forward so long as economic conditions allow.¹³ Fares are a critical component of TfL's budget, generating over £5 billion annually, accounting for a significant portion of TfL's overall income and that of the GLA Group.

TfL's Spending Review Phase 2 Outcome, which included a £2.2 billion settlement, noted that the "funding in this settlement is provided against an assumed scenario that overall TfL fares will rise by the value of RPI+1 for each year of this settlement."¹⁴

The Committee recognises that the final decision will be made during the 2026-27 budget process. However, given the scale of fares income and the potential impact on both transport affordability and TfL's finances, it is important that there is transparency regarding the scenarios under consideration and how these might affect future fare levels. In response to this letter, the Mayor should outline what economic conditions would prevent him from implementing a fares freeze in March 2026 or subsequent years of this term.

Rail Devolution

We considered your manifesto commitment to "explore greater devolution of rail and end the misery of non-TfL rail lines letting Londoners down." The Assembly has long supported this ambition and

has called on the Government to devolve more rail services to TfL, recognising TfL's strong track record in improving service quality—most notably with the transformation of the London Overground.¹⁶

Currently, Richard Watts told us that, "We are furthest engaged in discussions around Great Northern...We are actively lobbying and campaigning for this and we are doing the necessary officer work in partnership with the civil service at the same time."¹⁷ However, we note a lack of clarity around which other lines are being prioritised for devolution beyond Great Northern. In response to this letter, the Mayor should set out which rail routes he sees as a priority for devolution, and provide an update on the status of discussions with Government.

The Committee raised concerns about fare parity, particularly the risk that devolved rail services could become more expensive than travelling on the Underground. At a recent Mayor's Question Time, you have committed to "harmonising" the Tube and rail fares to ensure Londoners don't pay more to travel on a TfL train than the TfL Tube. The Committee supports this commitment and believes it must be upheld as part of any future devolution arrangements.

Universal Free School Meals

"Work to make universal free school meals permanent for all state primary school children" was one of your headline manifesto commitments. ¹⁹ The Committee has previously welcomed the programme's positive impact on children's health and wellbeing and supported your announcement earlier this year that the programme will be funded for at least a further three years. ²⁰ However, we have also raised concerns about the adequacy of the funding rate per meal.

The GLA funded meals at £2.65 per meal in the first year, increased this to £3.00 in the second year,²¹ and will maintain the £3.00 rate for the 2025-26 academic year.²² While this is higher than the national government's rate for universal infant free school meals (UIFSM), which was increased to £2.61 per meal for 2025-26,²³ a 2024 independent review addressed to the government recommended an increase to £3.16 which should then be indexed to inflation.²⁴

We heard from Richard Watts that "For administrative ease, [the GLA] assume every school at the moment has an 87 per cent take-up rate...and schools, if they get a higher take-up rate - which a small number do but not that many - then they can effectively come back through their local authority and recoup the money back from us." Fay Hammond also informed us about plans to "give additional money for children perhaps with Special Educational Needs (SEN)."

The Committee considered the implications of the Government's recent decision to extend free school meals to families receiving Universal Credit, starting in September 2026. While Richard Watts noted that "potentially quite a significant more number of people will be funded by the Government instead of the Mayor," ²⁶ the financial implications for the UFSM programme remain unclear. ²⁷ In

particular, it is uncertain how this change will affect the number of children eligible under the GLA scheme, the overall cost to the GLA, and the adequacy of the per-meal funding rate. In response to this letter, the Mayor should clarify how the Government's expansion of free school meals to families on Universal Credit will affect the cost, scope, funding, and price per meal of the UFSM programme within the GLA budget.

Making London fairer

The Committee considered your manifesto commitment to deliver 40,000 council homes by the end of the decade. We examined whether acquisitions would count towards this target. Your Mayoral Head of Delivery Jamilla Hinds-Brough noted that acquisitions have "been a key part of our ability to achieve targets around council homes in London, and I am sure that will continue to be the case." It is unclear what proportion of the Mayor's 40,000 council homes will be delivered through acquisitions compared to new construction. In response to this letter, the Mayor should clarify the extent to which his commitment to build 40,000 council homes by the end of the decade will be delivered as new builds and how many through acquisitions.

In the broader context of housing delivery, the Committee also discussed the Government's new target of 88,000 homes per year for London. While not directly linked to your manifesto, this target – alongside nearly £12 billion allocated for the Social and Affordable Homes Programme—will have implications for your commitments on housing. Richard Watts acknowledged that "the 88,000 [target] is not London's legal target," but recognised it as a clear signal of Government intent. He explained that the GLA will need to work with boroughs and Government to allocate this figure "on the basis of some sense of availability of land and other building opportunities", and that this process will be reflected in the forthcoming draft London Plan. We agree that building 88,000 homes a year is ambitious, especially given the concerns we have heard around operational barriers, such as a possible backlog of Stage 2 referrals in the planning process. The Committee is concerned that such operational barriers could further impact the pace of delivery and the effective use of available funding, and will seek to follow up on this in future scrutiny.

I would like to thank Richard Watts, Jamilla Hinds-Brough, and Fay Hammond for their time and valuable contributions. I look forward to your response to this letter by **29 November 2025**.

The Q1 2025-26 Greater London Authority Group performance reports

I am writing to you on behalf of the Budget and Performance Committee, following its review of the published results of the GLA Group for the first quarter of 2025-26.

The Committee see these monitoring reports as a vital part of its scrutiny process and recognise the value of them as a key publication for Londoners to understand how the GLA Group is delivering on its objectives through the use of its £20 billion annual budget, which is largely publicly funded. This Committee would like to take this opportunity to recognise the improvements made to the format and content of the MOPAC quarterly performance report.

13 period reporting

The GLA:Mayor budget is the GLA's specific component budget focusing on the Mayor's strategic priorities expressed through the eight themes of housing, social justice, environment, health, skills, children and young people, economy and global city and culture. The 2025-26 budget totals over £2.5 billion.

The Q1 2025-26 GLA: Mayor finance report noted that the "year-to-date data presented in this report is based on Period 3 of the 2025-26 financial year (which ended on 21 June 2025). "2 This was the first indication this Committee received that the GLA had adopted a 13-period year reporting approach. Under this approach, the financial year is divided into 13 periods of four weeks. The 'quarter' represented in the Q1 report appears to span three four-week periods.

By comparison, under the previous approach, the financial year was divided into four quarters of three calendar months. The 2024-25 reports were clear that the quarter was based on a three-month period. The Q1 2024-25 GLA:Mayor finance report stated that "This report provides a summary of the financial position for the GLA: Mayor... at end June 2024." Similarly, the Q2 and Q3 2024-25 reports stated that they cover the financial position at the end of September⁴ and December⁵ respectively.

The Committee is concerned that this change has been made without clear communication to the users. The impact of this change compared to previous practice includes:

- Financials on a quarterly basis are no longer comparable with previous years as they are based on different lengths.
- Financials are no longer comparable with periods in the same year as there will now be a combination of 16-week and 12-week quarters.
- Financials will no longer align with the publication of key underlying activity such as the delivery of affordable homes where the statistics for starts and completions are reported against three-month quarters.

The Committee understands that this results from the use of TfL financial accounting system for the GLA's financials. The TfL financial accounting system is configured on a 13-period basis, which is a common approach in the transport sector. A 13-period year also aligns to the salary payment of staff employed by the GLA.

It is the Committee's view that the GLA should use the flexibility it has for internal reporting to choose the reporting formats that are the most effective. However, for external reporting the GLA should use a consistent and comparable approach. Where changes are unavoidable these should be clearly communicated, and the impact of any change clearly set out. The GLA should clearly set out when and why a 13-period year reporting approach was adopted in its quarterly reporting and publish financials that align with its output delivery reporting from its Q2 2025-26 report onwards.

GLA:Mayor performance

Prior to 2024-25, the GLA's quarterly reporting consisted of a finance report supported by a series of detailed dashboards that covered performance against the relevant performance indicators and highlighted the top risks and issues. The publication of these dashboards was suspended from Q1 2024-25, and since then, there has been no information of the GLA's performance included in its quarterly reporting.

The Committee understands that a new performance framework is in development but remains concerned by the length of time that the performance has been missing from the quarterly reports. The Committee see these reports as a key communication tool that gives Londoners the confidence that the GLA is delivering on the Mayor's priorities effectively, and allows the Assembly to scrutinise the GLA's delivery. The Committee would like the GLA to commit to the publication of full performance reports covering the full GLA:Mayor budget by Q4 2025–26.

2025-26 Budget amendments

The 2026-27 Mayor's Budget Guidance states that the GLA and functional bodies should comply with Chartered Institute of Public Finance and Accountancy (CIPFA) guidance on making changes to approved budgets, which states that "it may be necessary to revisit the budget and spending plans after their formal approval and adoption, although this should only be considered in the event of exceptional matters and significant change, where the approved budget no longer has meaning and relevance to the organisation's priorities and purpose." This Committee supports this approach, and is concerned that budget changes have been made that are not justified by this criteria.

The 2025-26 Budget was approved by the London Assembly and Mayor in February 2025. The Q1 2025-26 quarterly performance reports include changes to the 2025-26 Budget since it was approved. Although these budget revisions are now set out in quarterly reports, following improvements promoted by this Committee, we remain concerned that significant changes are being made to the approved budget without clear explanation. Where revisions are set out, reports still lack supporting detail, which means the changes cannot be fully understood by this Committee and Londoners more widely. The Committee is particularly concerned by the amendments in the budgets for TfL capital renewals and the GLA's Affordable Homes Programme, as set out below.

TfL capital renewals

The TfL 2025-26 Budget for capital renewals has been cut by £297 million. This is 27 per cent of the approved 2025-26 Budget. TfL's quarterly performance report for Q1 2025-26 notes the impact of economic conditions, stating: "We have mitigated many of the headwinds and pressures we are facing by going further on revenue and reviewing our investment in core asset renewals to ensure it is deliverable in year, we have the right scope and it is fully prioritised with no impact on safety, reliability and revenue." This provides only a broad explanation of why there may be less money available, without detailing the impact of the budget change or why this specific reduction was decided. Without any supporting explanation it is difficult for this Committee and Londoners not to see this as a concerning issue.

The Committee believes the maintenance of the TfL network is a key priority, with evidence from TfL last year indicating the importance of funding for this area. At TfL's 3 October 2024 Programmes and Investment Committee, a paper on the London Underground Renewals reported that: "Budget constraints have reduced investment in all our renewals and we are beginning to see service impacts resulting from the degrading asset base." The paper goes on to state: "From 2018-19 to 2023-24 the level of funding allocated has been insufficient to maintain the [State of Good Repair] of the network. This will lead to an increased impact on customer service and continue to build a backlog of works to be completed in future. Where continued safe operation of assets is not possible, closures or service restrictions will take place." The paper tracks the 'incidents on the [London Underground] network relating to Asset Condition decline': between 2018-19 and 2023-24 these increased by 185 per cent, from 4,195 to 11,944. A reduction in the approved capital renewals budget will almost certainly affect TfL's capacity to address these issues. We need a full explanation of both the reasons for the change and the likely impact.

Affordable Homes Programme

The approved 2025-26 Budget for the current affordable homes programme has increased by 29 per cent from £1,069 million to £1,380 million which is a budget increase of £311 million.¹³ The supporting commentary does state that "The programme budget was increased due to additional funding provided by MHCLG for the programme."¹⁴ However, it remains unclear about why this additional funding was allocated or what the impact will be on delivery. This Committee would like to see a clear explanation of why the budget needed to change and what the impacts are for delivery whenever changes of this scale are required to the approved budget.

It is the Committee's view that the GLA and functional bodies should follow the Mayor's Budget Guidance and only change budgets in year when it is clear that "the approved budget no longer has meaning and relevance to the organisation's priorities and purpose". Any change that is made to the budget after it has been approved should be supported by a clear commentary covering why the change has been made and what the impact is.

To summarise, the Committee would appreciate if you could respond to us on the following points:

- 13-period reporting: setting out when and why a 13-period year reporting approach was adopted, and committing to publish financials that align with the GLA's output delivery reporting from the Q2 2025-26 report onwards and allows for comparison with previous years.
- Performance reporting: committing to the publication of performance reports covering the full GLA:Mayor budget by Q4 2025-26.
- Budget changes: confirming that the GLA and functional bodies will follow the CIPFA criteria cited for budget changes as stated in the Mayor's Budget Guidance criteria, and where changes are made, provide clear commentary covering the reasons and impact.

We appreciate GLA officers' work on producing these key reports and we look forward to assessing the performance against the 2025-26 Budget in the coming quarters with the above reflections in mind. I look forward to your response to this letter by **15 November 2025**.
