1. Executive Summary

- 1.1 At the London Assembly (Mayor's Question Time) meeting on 11 July 2025 the Assembly resolved:
 - "That, in relation to urgent matters only, a general delegation of authority in respect of the Authority's powers and functions (apart from those that cannot under the Greater London Authority Act 1999 be delegated) be given to the Chair of the Assembly, in consultation with the Chair of the GLA Oversight Committee, party Group Leaders and relevant Committee Chair(s), from the close of this meeting until the next meeting of the Assembly, which will be the London Assembly (Plenary) meeting on 4 September 2025."
- 1.2 Accordingly, the Chair of the Assembly is now asked, following consultation with the Chair of the GLA Oversight Committee and party Group Leaders, to sign jointly with the Mayor a petition addressed to His Majesty the King seeking the transfer of the former Greater London Council's (GLC) Coat Arms to the GLA.

3. Decision by an Assembly Member under Delegated Authority

Background and proposed next steps:

- 3.1 Further to discussions between the Mayor and London Assembly and further to <u>Mayoral Decision</u>
 3319 the GLA proposes to submit a formal petition to His Majesty the King, via the College of Arms, for the transfer of the former Greater London Council's Coat of Arms to the GLA.
- 3.2 A Coat of Arms is a unique symbol representing an individual, family, dynasty, state, or organisation. Its use is regulated by the College of Arms. It is proposed that the transfer of the former GLC's Coat of Arms to the GLA would be conducive to the GLA's functions, exercisable by the Mayor and the London Assembly.
- 3.3 Key functions of the Mayor include taking Mayoral decisions to further the GLA's principal purposes of promoting economic and social development and the improvement of the environment in Greater London. Key functions of the London Assembly include scrutinising the Mayor's activities, holding him to account and investigating matters of importance to Greater London. Public awareness of, and trust and confidence in, the GLA is key to the effective discharge of these functions. Many of these functions also depend upon public participation. Securing the transfer of the former GLC's Coat of Arms is considered to be conducive to these matters and therefore the exercise of these functions because it will help further entrench the identity of the GLA within London, and amongst the public, and will help to build the fabric of new City Hall as a civic space for London with strong roots and connections to London's proud devolved history.

- 3.5 The exercise of delegated authority to sign the petition will be formally noted at the next appropriate meeting of the London Assembly.

TO THE KING'S MOST EXCELLENT MAJESTY

The Humble Petition of Sir Sadiq Khan, Knight, One of Your Majesty's Most Honourable Privy Council, Mayor of London, and of Leonard Lloyd Duvall, Esquire, Officer of the Most Excellent Order of the British Empire, Chair of the London Assembly,

SHEWETH

THAT by Letters Patent under the hands and Seals of Garter, Clarenceux and Norroy and Ulster Kings of Arms bearing date the First day of September 1965 certain Arms were granted and assigned unto the Greater London Council and that by further Letters Patent under the same hands and Seals bearing date the Fifth day of October 1966 a Device or Badge was granted and assigned to the said Greater London Council

THAT pursuant to the Local Government Act 1985 the said Council ceased to exist on the First day of April 1986

THAT pursuant to the provisions of the Greater London Authority Act 1999 the Greater London Authority was established in May 2000 to be an Authority for Greater London and to consist of the Mayor of London and an Assembly for London to be known as the London Assembly, which Authority was empowered amongst other things to do anything which it considered would further any one or more of its principal purposes as set out in the said Act

AND THAT, the said Authority being desirous of bearing and using the Armorial Ensigns granted and assigned as aforesaid, Your Petitioners as Mayor of London and as Chair of the London Assembly most humbly pray Your Majesty's Royal Licence and Authority that the said Armorial Ensigns be transferred unto and exemplified in the name of the Greater London Authority, to be borne and used by the said Authority on Seals or otherwise according to the Laws of Arms

AND Your Majesty's Petitioners will ever pray, etc.
