

In accordance with Section 100B(4)(b) of the Local Government Act 1972, I have agreed to admit one item of urgent business to the agenda, in order to consider, at the earliest opportunity, summoning:

- the Mayor of London, in his capacity as occupant of the Mayor's Office for Policing and Crime; and
- the Deputy Mayor for Policing and Crime

to attend a meeting of the Committee; and to consider summoning the Metropolitan Police Service's draft Estates Strategy and related documents, which are understood to be in the possession of MOPAC.

Can I ask the Committee to:

- (a) **Agree** to hold a meeting on Thursday 18 December 2025, at 1pm or the rise of the London Assembly Mayor's Question Time meeting, whichever is latest, principally to put questions to the Mayor of London, as occupant of the Mayor's Office for Policing and Crime, and the Deputy Mayor for Policing and Crime on the Metropolitan Police Service's draft Estates Strategy;
- (b) Under provisions of Section 33(5) of the Police Reform and Social Responsibility Act 2011, **to require** the attendance of the Mayor of London, Sir Sadiq Khan, in his capacity as the occupant of the Mayor's Office for Policing and Crime, and Kaya Comer-Schwartz, Deputy Mayor for Policing and Crime, at the meeting of the Police and Crime Committee which will take place on Thursday 18 December 2025, at 1pm or the rise of the London Assembly Mayor's Question Time meeting, whichever is latest, for which notice will be given in due course in accordance with Section 62 of the Greater London Authority Act 1999 (as amended) (as per Section 33(9) of the Police Reform and Social Responsibility Act 2011), to answer questions on why the Police and Crime Committee has been excluded from **receiving** a copy of the Metropolitan Police Service's draft Estates Strategy or been provided

with an opportunity to comment on its content **as part of the Committee's oversight and scrutiny role;**

- (c) Under provisions of Section 33(5) of the Police Reform and Social Responsibility Act 2011, **to require** the Mayor of London, Sir Sadiq Khan, in his capacity as the occupant of the Mayor's Office for Policing and Crime, to provide the Police and Crime Committee with the documents listed below, for which notice will be given in due course in accordance with Section 62 of the Greater London Authority Act 1999 (as amended) (as per Section 33(9) of the Police Reform and Social Responsibility Act 2011), and with the documents to be provided no later than two weeks from the date of the notice requiring these documents:
- a. A copy of the Metropolitan Police Service's draft Estates Strategy;
 - b. Additional documents associated with the draft Estates Strategy provided to the London Policing Board – including briefing documents and advice; and
 - c. Feedback provided by stakeholders on the draft Estates Strategy.
