According to the ambition of regeneration projects going in London in the past years, I would like to object the fact, that companies like Peabody and Bexley council, with the backing of government does not provide the homeowners, who will be affected from the Regeneration with fair compansation. Please, stop this inappropriate practice if you really want to help londoners and homeowners, not only regeneration companies.
