Welcome to the autumn 2015 edition of the RE:FIT newsletter! Focused on public sector organisations in London, the newsletter will keep you up to date with the programme's recent developments and opportunities, as well as highlighting some of the specific projects underway.

WHAT'S NEW?

The RE:FIT team has enjoyed a busy summer, supporting and helping to progress our new and existing public sector clients through their energy, cost and carbon saving projects. A number of high profile and prestigious organisations have signed up to RE:FIT, including **Museum of London, Royal Parks, London Zoo (Zoological Society of London), Bloomsbury Colleges and Historic Royal Palaces (including Tower of London!)**, as well as schools around London.

Projects progressing through mini-competition stage over the last quarter include the **Bank of England, Imperial College London, the University of East London and the London Borough of Greenwich**. We look forward these organisations starting their projects with their appointed Energy Service Company (ESCo) and making progress to save costs, energy and carbon.

We are delighted to report that RE:FIT has far exceeded the target set by the European Investment Bank (EIB) as a condition of its funding of the RE:FIT Programme Delivery Unit, by levering in 37 times the amount invested by the EIB (against a target of 25 times) – a total of £76.4 million.

The Greater London Authority and Local Partnerships have recently issued an invitation to tender for the next incarnation of the RE:FIT framework, which should be up and running early next year. Additional information is available through the Crown Commercial Service portal.

RE:FIT CLIENT NETWORK EVENT

In September 2015, we ran the first in a series of new free of charge events for existing and prospective RE:FIT clients. These events are an opportunity for you to meet other organisations running, developing, funding or supporting retrofit projects - to share experiences, best practice and solutions, to speed up and optimise energy, cost and carbon savings across London.

Representatives from 'green' funding organisations and measurement and verification companies outlined how their services and solutions can help optimise RE:FIT projects.

There were also presentations from RE:FIT clients about their projects, covering their experiences, what worked for them and lessons learned. These were followed by lively Q&A sessions.

This enjoyable and informative event proved a great success, with constructive and positive feedback from all participants. The next workshop will take place in the next couple of months.

RE:FIT SIGNS UP MORE HIGH PROFILE ORGANISATIONS

RE:FIT HEALTH SECTOR PROJECT UPDATE

The RE:FIT programme continues to grow strongly within the health sector and is currently supporting the following organisations to deliver their RE:FIT projects. Please visit <u>RE:FIT website</u> for case studies.

Whittington Health NHS Trust

Whittington's ESCo, appointed after a successful RE:FIT minicompetition, has completed the Phase 1 investment grade proposal. This sets out the energy conservation measures to be installed, as well as the guaranteed annual cost, energy and carbon savings.

Epsom and St Helier NHS Trust

Epsom and St Helier are working on Phase 1 works with their appointed ESCo. These include large scale building fabric measures – new external cladding, roofs and windows – across the Trust's two hospitals.



NHS Property Services

We are working with NHS Property Services to start their minicompetition by the end of this year. The organisation is looking to drive energy efficiency throughout its very large building stock, potentially including measures such as LED lighting, controls and solar PV.
