

# London History Schools Day Competition

1. The Promoter of the London History Day at Schools photo competition prize draw is the Greater London Authority (GLA) of City Hall, The Queen's Walk, More London, London, SE1 2AA.
2. Entry is only open to UK residents excluding employees of [the Greater London Authority, Transport for London, London Legacy Development Corporation, the Mayor's Office for Policing and Crime, the London Fire and Emergency Planning Authority or any of their subsidiaries advisers, agents and/or anyone connected with the organisation of this promotion. If you are using your work computer, you may need to obtain your employer's permission prior to entering.
3. A teacher must enter a child/group of students by posting a photo using the official London History Schools Day hashtag on social media – #LondonHistorySchoolsDay. Teachers must have the necessary parental/guardian permission before doing so. Any entry not made not using the official hashtag or which is incomplete, illegible, defaced or a copy of an official image will be rejected.
4. Photos must be in the spirit of London History Schools Day, a celebration of London's unique history and heritage.
5. There is no limit to the number of entries which may be made.
6. The Competition begins on Friday 24 May 2019 ("the Opening Date") and runs for one day until Saturday 25 May 2019, 12.00am ("the Closing Date"). Entries to the Competition must be made via social media to arrive no later than 25 May.
7. The prizes for the Competition are tickets for two classes from two schools to the Beasts of London Exhibition at the Museum of London.
8. The terms of the tickets are as follows:
  - a. Maximum of one class of up to 35 children
  - b. At least one adult to attend for every five students
  - c. Any adults above this ratio will need to cover the costs of the ticket
  - d. Bookings will need to be made before the end of the summer term and visits should take place in summer term or the first half of autumn term.
  - e. Once a booking has been made, we are unable to change the date of that booking (at the discretion of our Box Office).

10. The winners will be the entrants who in the sole opinion of the judges completes the tie-breaker in the most apt and original way.

11. Winning entrants will be notified via their school using the contact information provided no later than 31 May. If the GLA is unable to contact any winner, or if any prize is not claimed within 10 days of being notified the winner will be deemed to have forfeited their prize. In such instances, we will choose a new winner for that prize. The name of the winning schools will be posted on the GLA website.
12. The GLA will notify the Museum of London via email of the winning schools.
13. The winners will need to arrange their tickets with the Museum of London before the end of the summer term.
14. Prizes will be sent to winners at the address shown on their entry form within [14 days] of [the closing date].]
15. Winners may be required to take part in promotional activities.
16. The judges' decision is final and binding in all matters and no correspondence will be entered into.
17. The Promoter reserves the right to substitute any prizes with a prize of equivalent or higher value in the event of circumstances outside of its control. Prizes are non-transferable. There is no cash alternative to prizes.
18. Entry into the Competition implies acceptance of these terms and conditions. The Greater London Authority reserves the right to refuse to award prizes to anyone found to be in breach of these terms and conditions.
19. The GLA reserves the right to cancel the competition at any stage if it considers such action necessary, or for reasons beyond the GLA's reasonable control, and the GLA will have no liability to the entrants in respect of any such cancellation.
20. These terms and conditions are governed by English Law and shall be subject to the exclusive jurisdiction of the English Courts
