**BACKGROUND**

- a) The Mayor has previously delegated his powers to Transport for London (TfL) to enable TfL to carry out work on his behalf in relation to aviation policy, and in particular airport capacity and airport provision affecting Greater London, in accordance with his formal Directions.
- b) These Directions have been time limited and the current Direction expires on 30 September 2015.
- c) For the reasons set out in the Mayoral Decision, the Direction is to be extended and the delegation is to be extended commensurately.


**Delegation**

- 1. Under section 38 of the Greater London Authority Act 1999 (GLA Act), I hereby delegate to TfL the exercise of the Mayor's powers under sections 30 and 34 of the GLA Act so that TfL may continue to exercise those powers in respect of proposals and policies for aviation to, from or within Greater London, including but not limited to assessing the Airports Commission's recommendations, Government policy in respect of airport provision and aviation capacity, and environmental and other effects of existing and alternative proposals, and any ancillary tasks.

**Conditions**

The delegation in paragraph 1 above is subject to the following conditions:

- a) The work carried out by or on behalf of TfL in implementing this delegation will be the subject of reports and advice to me on progress and developments;
- b) In implementing this delegation TfL will comply with any instructions or guidance issued by me or any officer I nominate; and
- c) TfL shall at all times afford the GLA's Monitoring Officer all reasonable co-operation and access to such documents and facilities as may be required from time to time in respect of that person's functions under section 5(2) of the Local Government and Housing Act 1989.

I, BORIS JOHNSON, MAYOR OF LONDON, in exercise of the powers conferred on me by section 155(1)(c) of the Greater London Authority Act 1999 ("the Act") hereby direct Transport for London:

1. to examine, review, assess, analyse, comment, and communicate and engage with the Government, the public, relevant experts, other public and private bodies, and the media, on issues relating to present and future Government policy in respect of aviation to, from or within Greater London, including but not limited to:
  - 1.1 airport capacity, airport operation, and aircraft movements;
  - 1.2 proposals, consultations and reports in relation to airport capacity, airport operation, and aircraft movements; and
  - 1.3 the effects of current airport capacity, airport operation and aircraft movements, and the likely effects of proposals as to airport capacity, airport operation, and aircraft movements, on all aspects of the environment in, all forms of transport to from and within, business in, and the inhabitants of, Greater London.
2. to do anything ancillary incidental or complementary to any of the above
3. that this Direction is time limited in its operation to 30 June 2016 and will be reviewed on that date.
